  - a. **Public Hearing** to consider Pleasant Grove City's proposal to permanently close and abandon the portion of 600 South between 350 East and 300 East. The proximity of the 600 South intersection with 300 East to the 300 East intersection with State Street poses safety concerns for motorists attempting turn in and out of 600 South. Additionally, UDOT plans to widen 300 East as it approaches State Street to allow for a double left turn on to State Street, which will further complicate access to 600 South. 600 South would still continue to the east connecting to 400 East and Apple Grove Lane. If the Council decides to close and abandon this portion of 600 South the existing right-of-way will be deeded to the adjacent property owners as required by State Law. (**SCRATCH GRAVEL NEIGHBORHOOD**)
