**A RESOLUTION OF THE MAYOR AND MUNICIPAL COUNCIL SITTING AS THE BOARD OF CANVASSERS ACCEPTING THE ELECTION RETURNS, DECLARING AND CERTIFYING THE RESULTS OF THE MUNICIPAL GENERAL ELECTION HELD ON NOVEMBER 6, 2018 AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Municipal General Election was held on November 6, 2018; and

**WHEREAS**, pursuant to Section 20A-4-301 et seq. of the Utah State Code, the Municipal Council and Mayor constitute the Board of Municipal Canvassers for Pleasant Grove City and do hereby canvass the returns of the General Election; and

**WHEREAS**, on November 20, 2018, the Board held a duly noticed meeting to canvass the results of the General Election as required by State Code.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of Pleasant Grove City, Utah, acting as the Board of Municipal Canvassers for Pleasant Grove City as follows:

**SECTION 1:**

The Board hereby certifies the results as shown by the Tabulation of Election Returns as supplied by the City Recorder as shown in Exhibit "A."

**SECTION 2:**

The Board hereby certifies that Proposition 8 enacting a CARE Tax for Community Arts, Recreation Enhancement received more FOR votes by the voters within the Board's jurisdiction, therefore Proposition 8 passed.

**SECTION 3:**

A certified report of the election results shall be prepared. A report of the canvass will be published in a newspaper of general circulation and posted in a conspicuous place. A copy of the Canvass will be filed with the Office of Lieutenant Governor for the State of Utah, all in conformance with State Law.

**SECTION 4:**

This Resolution shall take effect immediately upon its passage.
